Second Interview with E [REDACTED] F [REDACTED] - 108

3. Narrative

On November 16, 2022, at around 1155 hours, I meet with E [REDACTED] F [REDACTED] at her [REDACTED] office at [REDACTED], [REDACTED]. Present during the interview beside me and E [REDACTED] were her [REDACTED] [REDACTED] V [REDACTED], and Matthew When with the Nevada State Police Investigation Division. This was a follow up interview with E [REDACTED] related to the homicide in Moscow Idaho.

I asked E [REDACTED] who had the front door code. E [REDACTED] told me the following people had the door code.

- Ethan Chapin

- H [REDACTED] J [REDACTED]
- E [REDACTED] A [REDACTED]
- J [REDACTED] I [REDACTED]

E [REDACTED] stated the above named people were the only ones she knew had the code. E [REDACTED] stated the code for the front door was the same code from the year before. I asked E [REDACTED] what the code was and she stated it was [REDACTED]. E [REDACTED] stated Maddie was the only roommate who lived in the residence the year before. E [REDACTED] stated her, D [REDACTED], and Kaylee moved in around August 3rd, 2022. E [REDACTED] stated Ethan had his own apartment but she was not sure where it was located. E [REDACTED] stated Maddie kept her same room from the year before. Maddie's room was located on the 3rd floor on the east side of the residence next to the

bathroom.

I asked E [REDACTED] about Murphy's routine. Murphy was Kaylee's dog she had purchased when she was still dating J [REDACTED] D [REDACTED]. E [REDACTED] stated Kaylee would primarily take Murphy out but Maddie would also help. E [REDACTED] stated they never just left the door open because he would run away so they would have to use a leash when they took him out. E [REDACTED] stated Murphy would not bark that often and was very friendly. E [REDACTED] stated Murphy would primarily sleep in Kaylee's room and if Kaylee was not home he would be left in the room.

I asked E [REDACTED] about the Uber driver Maddie and Kaylee used on a regular basis. E [REDACTED] stated Kaylee knew him from other [REDACTED] who used him on a regular basis. E [REDACTED] stated they would either contact the Uber driver through the app or contacted him directly. E [REDACTED] stated the Uber driver was very friendly and was always nice to everyone and everybody trusted him. E [REDACTED] was able to tell me the Uber driver was married and his wife had just had a baby. E [REDACTED] told me he drove a small car, possibly gray or black but she could not tell me more about the car.

I asked E [REDACTED] who in the house had a boyfriend. E [REDACTED] told me Xana was dating Ethan. D [REDACTED] was dating a boy named Q [REDACTED] who lived in Boise and went to BSU. Maddie was dating a J [REDACTED] S [REDACTED] who lived in Boise. Kaylee was dating J [REDACTED] D [REDACTED] but had recently broke up with him. Kaylee was possibly hanging out with M [REDACTED] E [REDACTED]. E [REDACTED] stated M [REDACTED] was Xana's big in the Greek system. E [REDACTED] stated the relationship was new and that he had never stayed over at the house but Kaylee had stayed with him possibly more than once. E [REDACTED] stated Kaylee was also talking too an E [REDACTED] F [REDACTED], also a [REDACTED]. E [REDACTED] stated she did not have a boyfriend but did mention she was kind of hanging out with a K [REDACTED] D [REDACTED] who is a [REDACTED] but they were not serious.

I asked E [REDACTED] if she had ever heard of a C [REDACTED] G [REDACTED]. E [REDACTED] stated she knew of a C [REDACTED] and he was also a [REDACTED]. E [REDACTED] stated C [REDACTED] was a nice guy and knew D [REDACTED].

I asked E [REDACTED] if she knew a C [REDACTED] E [REDACTED] and she stated she did not. I asked E [REDACTED] if she knew the person behind Kaylee and Maddie on the Grub Truck video. E [REDACTED] stated she did not know who the person was. I asked E [REDACTED] if she knew a guy buy the name of S [REDACTED]. E [REDACTED] stated she did not know him but stated she had heard from a friend of Maddie's, S [REDACTED], that her boyfriend J [REDACTED] E [REDACTED], also a [REDACTED], that he would never want to get in a fight with S [REDACTED] as he had anger issues.

I asked E [REDACTED] about who paid for the Spectrum wifi account. E [REDACTED] told me it was Kaylee who paid for the account. E [REDACTED] told me the log in for the password was [REDACTED] and the wifi name was [REDACTED]. E [REDACTED] stated she did not know what the actual user name and log in was for the account.

I asked E [REDACTED] if she knew of anyone who had gotten asked to leave any of the parties thrown at the house. E [REDACTED] stated two guys from the [REDACTED] house, J [REDACTED] H [REDACTED] and another guy only she knew as F [REDACTED] got in a fight and were told to leave. E [REDACTED] stated this fight occurred about a month before the incident at the house.

I asked E [REDACTED] about an A [REDACTED] C [REDACTED]. E [REDACTED] said A [REDACTED] used to live at the house but moved out. I asked E [REDACTED] who used the bedroom on the west end of



the 1st floor. E█████ stated Kaylee and Maddie used the room as an office. E█████ stated Kaylee would use it for her work and had a computer in it.

I asked E█████ if any of the girls who lived in the house had jobs. E█████ told me Maddie and Xana both worked at Mad Greek on Main Street. E█████ told me Kaylee worked for an online company and worked from home. E█████ did not know who the company was. E█████ told me Maddie also looked for an online company but it was not the same company. E█████ said the company Maddie worked for was out of Boise and during the summer she had worked for them in their office in Boise.

I asked E█████ about the drug use in the house and who used. E█████ told me Ethan and Xana both took Adderall when they drank alcohol. E█████ told me she saw Ethan and Xana both use Adderall the night before the murders. E█████ told me she saw Ethan take a pill and she saw Xana crush up a pill and snort it by using a rolled-up bill in her room. E█████ also said she thought Kaylee also used Adderall but was not sure.

I asked E█████ if she has had any issues from any of the other people who live around them. E█████ stated besides the 3 to 4 noise complaints they had there were no other issues.

E█████ told me Kaylee would look up who the registered sex offenders who lived in the area. E█████ stated Kaylee had found a registered sex offender who lived close to them in the blue apartments on Queen. Kaylee stated he was older in his 30's to 40's. E█████ stated Kaylee was looking at the sex offender registry within the week or so before the murders. E█████ stated Kaylee was into crime shows. E█████ stated there was nothing that happened to prompt her to look up the sex offender registry.

I asked E█████ about two other incidents were Kaylee had mentioned some weird things had happened. E█████ told me about an incident at WinCo where a male had followed her around the store, watched her check out, and then followed her to her vehicle. Xana was waiting in the vehicle. E█████ stated Kaylee said the male was African American and in his late 20's. E█████ felt it happened sometime before Halloween, so mid to late October. E█████ stated Kaylee purchased a case of White Claws for Xana.

E█████ and her roommates had found the door open on November 4th at around 1057 and they entered the house and grabbed golf clubs out of the west 1st floor bedroom. E█████ and the other roommates walked around the house with the golf clubs to check the house. Kaylee was not home for this incident as she had gone home for the weekend. Wind was blowing and the screws on the hinges were loose and Xana's dad fixed it before he left that weekend.

Kaylee told everyone about an incident where she saw a male watching her when she had taken Murphy out back to go to the bathroom. E█████ could not remember when this happened but she could not provide an actual day. E█████ stated she had been at a Chapter meeting at the time Kaylee called them asking them if they were going to be home soon.

The following is a timeline of events of November 12, 2022 to November 13, 2022.

E█████ stated she was the last one in the house to wake up and when she got up Ethan was in the house in the living room and Kaylee, D█████, Maddie, and Xana were all gone. E█████ felt she got up sometime between 10 and 11 in the



morning. B█████ stated she checked her Find My Friends app and saw they were at Taco Bell at the time. Once Kaylee, D█████, Maddie, and Xana got back they started getting ready for the day. Kaylee, D█████, Maddie, and B█████ were in Kaylee's room and they were getting ready for a party at ██████ Taylor Street (The Whites). The house belonged to B█████, S█████, and K█████. The apartment is located on the second floor on the far east side of the apartment building. B█████ stated this was between 11 to 12 in the afternoon. B█████ stated Kaylee left for The Whites before the rest of the group. B█████ stated she left at around 2 pm with Maddie, D█████, Xana, Ethan, H█████, J█████, J█████, Ly█████, K█████, A█████ B█████, and S█████ S█████.

B█████ stated she started drinking at around 1130 or 1200 when still at 1122 King Road. B█████ stated she was drinking Mimosa's and High Noon's throughout the night. B█████ also stated she also played a drinking game called Rage Cage later in the night. B█████ felt she drank a 12 pack of High Noon's during the night, 2 Mimosa's in a standard wine glass. B█████ was unsure of what she had been drinking when she played Rage Cage.

B█████ stated she was at The Whites up until around 1548 hours when she left with Xana. Maddie, Kaylee, and D█████ stayed at The Whites. Ethan had left before her and Xana. B█████ and Xana went to A█████ B█████ place, somewhere on Taylor. B█████ and Xana left there at around 1651 and went back to 1122 King Road. B█████, Xana, Maddie, Kaylee, and D█████ were all at the house and made food. Ethan was not at the house during this time. At around 1800 hours B█████, Xana, Maddie, Kaylee, and D█████ all went to take a nap and they all set alarms for 2000 hours. B█████ got up at 2000 hours.

Once they all woke up they got ready to go to the ██████ for a house party. Maddie and B█████ left first to go to B█████ apartment at ██████ at around 2100 hours. Kaylee stayed home and was not going to go to the party at ██████. Ethan and Xana came over to the party after B█████ and Maddie. D█████ did not come with the rest and walked over at a later time. Maddie was not there for very long and she went back to the house to go to the club with Kaylee. B█████ felt Maddie left sometime after 2109 hours.

One of B█████ friends, Y█████ A█████, got to the ██████ and hung out with her. B█████ stated Y█████ showed up at around 2200 hours. They stayed in one of the apartments for a little longer and she and Y█████ went up to the main house for the ██████ fraternity. B█████ stated this might have been around 2230 to 2245 hours.

B█████ states he hung out in the main part of the house for a while and before she left the ██████ fraternity she saw Ethan and Xana in B█████ apartment. B█████ stated this was at around 0017 hours.

B█████ and Y█████ went to A█████ house again on Taylor. B█████ stated her, J█████, H█████, K█████, and Y█████ were the only one at the house.

B█████ stated she walked home at around 0100 hours and D█████ and I█████ M█████ were the only one in the house. B█████, D█████, and I█████ were watching Vampire Diaries for a while and at around 0122 hours I█████ left. D█████ went to her room after I█████ left. At around 0200 hours Kaylee and Maddie came home. Maddie, Kaylee, D█████, and B█████ went up to Kaylee's bedroom once they got home. Kaylee was getting ready for bed as they were hanging out in her room. B█████, Maddie, and D█████ went downstairs and Maddie and B█████ took Murphy outside to let him go to the bathroom. B█████ only



stayed outside for a short time and she then went back into the house and put something away in her cupboard and grabbed a bag of chips. B went downstairs to go to bed.

B stated nothing was unusual about Maddie and B demeanor when they got home. B stated they both appeared to be happy. B said Maddie was highly intoxicated and she had not seen her at that level of intoxication for a very long time.

B said when she went to bed she was using her iPad to watch a TV show off of Hulu. B, she said she was watching Baby Daddy. B could not remember what episode she was watching or how long she was watching. As she was watching the show Maddie came down stairs and asked her if she had Murphy with her because she could not find him. B told her no. B said her door was locked and she normally locks her door when she goes to bed. B told me she eventually turned off the show and her iPad and went to sleep.

B said she woke up after falling asleep to hearing what she felt was a firecracker go off and she thought she saw a sparkler going off through the crack under her door. B stated she did not know what happened. Either B called D or D called B and D stated she thought she had just seen someone dressed in all black in the house. B said Xana had been wearing all black. D responded by saying she thought he had a ski mask on. B said she didn't really know what to say to what D said. B admitted both her and D get scared easy. B even thought maybe one of Ethan's frat brothers could have been playing a joke. B told D to come down to her room and D ran down to her room.

B tried calling Kaylee, Maddie, Xana, and Ethan's phones and nobody answered. B said it was normal for Kaylee, Maddie, Xana, and Ethan not to answer if they were sleeping if she called late at night. B looked at her phone and it showed B called D at 0419 and at 0420 D called B back. During the call B asked D if she heard a firecracker and D said she did. B could not recall if it was during this call where D was talking about seeing someone in black walking in the house.

Once B and D were in B room together they continued to talk about what they heard and saw. B told me D said the male in black was walking out the back door and they had made eye contact with each other. B said D said the male was white with a big nose and that he was possibly holding a small vacuum type object.

B and D did not call 911 at the time because B thought D was imagining what she was talking about. B stated both her and D were both still drunk and they were very groggy.

B told me prior to hearing the firecracker she thought she heard Murphy bark she also heard what she thought was the beer pong table moving and cups falling. The beer pong table was located in the living room which is above B bedroom. B stated she was not sure what the sequence of events were for sure but she knows she heard Murphy bark, the beer pong table, and then the firecracker first before she called D to see if she had heard the same thing.

B told me she tried calling Xana and Maddie at 0421 and then tried calling



Ethan at 0422. B█████ stated she tried calling Maddie, Kaylee, and Xana several more times once D█████ got into her room.

B█████ told me when she went to bed she remembers most of the lights being left on inside the house.

B█████ told me after trying to contact the other roommates she fell back to sleep and then woke up at around 0730 and tried calling her Dad about her tooth. B█████ called her Dad again at 0800 but there was no answer, her house at 0801 with no answer, and then called her Mom at 0802 and he answered and asked to talk to her dad. Her dad called back at 0809 and he talked to him and eventually took Advil for her tooth. B█████ then fell back to sleep. B█████ woke up at around 1100 hours and noticed no one else in the house was up. B█████ stated she knew this because Xana's Snapchat location was not on and it should have been. B█████ and D█████ got scared because they should have been up. B█████ then called her friend J█████ and told her she and D█████ were scared and asked if she would come and get them. D█████ then called E█████ and asked her to come over. D█████ and B█████ knew E█████ was with H█████ so they knew he would come over with her.

H█████ arrived at the house and came through the front door. H█████ went up the stairs first and when she and D█████ went up the stairs H█████ turned around and told D█████ and B█████ to get out of the house and to call for help. B█████ stated she could see Xana on the floor of her bedroom. B█████ said Xana was wearing underwear and a sweatshirt. B█████ stated the door was partially open but stated the door should normally would be closed. B█████ called 911 and was trying to talk to the dispatcher but was having a hard time talking. B█████ had to give the phone to her friend J█████ so she could talk to the dispatcher.

I asked B█████ if she has ever seen Xana on the floor like she did that morning. B█████ told me she has never seen this but has heard Xana would pass out on the floor in the past when she is highly intoxicated. B█████ told me H█████ went back into the house. B█████ could not remember if J█████ and E█████ went into the house. B█████ told me she believed H█████ grabbed a knife from the kitchen when he went back into the house.

B█████ stated the police arrived as she was still on the phone and she disconnected with dispatch.

B█████ did not provide any further information related to this incident.
