

1314 hours: Meadows asked if Watts preferred a three car garage. Watts replied, "3 car garage. I will drive by the 6508 address when I get home."

1331 hours and 1359 hours: Utoft called Watts twice, briefly

1410 hours: Christina Meacham asked Watts, "What it's going on??? Where are you! We are so worried ☹️☹️☹️ WTF."

1411 hours: Watts sent another staged message to Shanann's phone, "Where are you?"

1414 hours: messages from Utoft were finally received by Shanann's phone (*by all accounts these would have been sent by Utoft earlier in the morning before she called police*). They included -

- "Just wanted to see if you were ok. I know you were hurting a lot last night. Hope you're ok."
- "Let me know how your appointment goes."
- "I have been to your house you (wont) open your door, your alarm is set, your shoes are sitting inside, your car's home, I am so very concerned about you right now. I need you to text me or call me and just tell me OK. If you don't wanna talk to nobody, you don't wanna be around nobody, I get it, its fine, but I need to know you're OK."

A group text was created between Cassie, Christina Meacham, Utoft, Addy and Shanann's phone. The group sent assorted messages of growing concern for Shanann

1426 hours: Watts told Christina the police "are here, call you when I know."

1546 hours: Addy asked Watts what was happening, "I'm so worried." Watts called Addy and held a six minute conversation

1548 hours: Addy told the group, "The police need to look at Chris' cell!!!! And computer"

Shanann's phone soon exploded with anxious messages of concern from friends and family across the nation. As the afternoon moved into evening the messages became gut wrenching pleas to hear from Shanann, sending her prayers, hope and their love

1622 hours: When Kellie Burke asked what the police were saying, Watts said "They will file missing person's report in the AM if we don't hear from her."

1626 hours: Burke asked Watts if Shanann was awake when he left for work. Watts lied and said, "I talked to her early this morning between 4-5am. I think she went back to sleep afterwards. She was still here when I left. Kids still sleeping." Burke said she was scared and Watts said he was too.

1701 hours: Kessinger made two unanswered calls to Watts

1705 hours: Watts called Chase Bank and held a nearly two minute conversation. He called a separate number for Chase moments later and held a two and a half minute conversation

1730 hours: Watts made an unanswered call to Kessinger

1748 hours: unaware of events Meadows asked if Watts drove by the 6508 Saratoga address. Completely aware of events Watts still replied, "Just did. Yup that's the exact model."

1800 hours: following suggestions by many, Watts searched Google for hospitals near his home

In less than four minutes Watts called Good Samaritan Medical Center (Lafayette), St. Anthony North Health Campus, Longmont United Hospital and UCHHealth (Broomfield) –

The average duration of these calls was forty seconds, the longest was sixty nine seconds. Out of curiosity I called St. Anthony's. Without identifying myself, I asked if a Rollo Tomasi was a patient. It took two minutes to get my answer. I suspect Watts merely called each hospital to create a trail of concocted concern and never actually spoke with anyone

1823 hours: Burke asked if Watts had any luck with the hospitals and Watts said "no luck at all"

1830 hours: Meadows asked Watts if Shanann was ok, noting she has not taken part in their group text exchange about selling the house. Watts replied, "She hasn't been around all day. It's very odd."

Yea people are helping me search. You don't need to get on a plane. We have a lot of support here."

1900 hours: Watts received a calendar notice titled, "Dinner with Shanann." Shanann had a similar entry, "Dinner with Chris", but scheduled for an hour later

0207 hours: Watts made an unanswered call to Kessinger. She called him back seconds later and they held a ten minute conversation

0458 hours: Sandy called Watts and held a four minute conversation

0632 hours: Sandy called again and held a six minute conversation

0726 hours: Watts perpetuated his fallacy, telling Sam "I'm hoping she's with someone I don't know about, because I've exhausted all the people I know of. I'm optimistic we will reunite again. People have been stopping by from time to time."

0929 hours: Watts transferred one last image into his Secret Calculator application, a semi-nude selfie of Kessinger

1208 hours: Kessinger spent nearly four hours searching Google and the internet for Watts, news outlets, and news accounts of Shanann's disappearance

1231 hours: Watts began to tell others that he was doing interviews with the news media

1336 hours: Watts told Sam an Amber Alert is not applicable to the facts as they are known presently. Watts added, "They just swept the house with dogs to pick up a scent." Watts said he has completed all his interviews with the news outlets

1421 hours: Watts added "Fox 31 reporter" to his contacts

1430 hours: Watts called Sandy and held a ten minute conversation

1504 hours: Watts told Addy, "Good Morning America has contacted my sister."

1700 hours: Kessinger searched Google on topics like "can cops trace text messages" - "How long do phone companies keep text messages" - "Difference between text message content and text message detail"

1800 hours: Watts had a calendar entry titled "Talk" scheduled to begin at this time

1821 hours: Kessinger searched the internet for news accounts of this incident and Shanann's name

These searches were conducted frequently by Kessinger throughout the next several days. She deleted every one afterwards

1826 hours: Watts told Nick Thayer that he was leaving now, stopping for gas and "I'll be there" (Watts had earlier agreed to spend the night at the Thayer's)

1842 hours: Watts returned a missed call from the Fredrick Police Department

As a result of that call Watts turned around and drove to the police department where he held an interview with FBI spanning 1900 hours to 2306 hours [FBI S17]

1859 hours: after a brief call to the Thayer's, Nick advised they would drive to the police department and wait for Watts to finish

2010 hours: Watts told Dave Colon that he was talking with the FBI presently

2042 hours: Nick told Watts, "Hey man. We are sitting outside thinking of you. I am talking to an investigator friend and she recommends maybe not to talking without a lawyer. I know this text might get there too late."

2304 hours: Watts added FBI Agent Graham Coder to his phone's contacts

Watts told an assortment of friends that he met with the FBI, "They have the case now"

0747 hours: Watts told his father, "Text me when you land. I can pick you up."

0903 hours: Coder sent a message to Watts, "Hey Chris, it's Graham from last night. Just checking in. Will you call me back?" Watts made that call three minutes later

0937 hours: Watts told Coder that his father just landed and he was "enroute to pick him up."

1013 hours: Watts told Coder that he just picked up his dad.

1027 hours: Coder told Watts, "Swing on by the PD when you get a chance. We'll make a game plan for today." Watts answered a short call from Coder a minute later

Frequently this day news outlets sent Watts messages requesting more interviews

At 1053 hours Watts resumed his interview with FBI and CBI. He eventually confessed murdering Shanann and disposing of all three bodies; he was subsequently taken into custody

1239 hours: Michael Feserman sent a message to Watts, "I don't think you will see this, but I hope you find peace in your struggles and I pray that you will find God - and have mercy on your soul."

As news broke of his confession and arrest, Shanann's phone received desperate messages from her friends and loved ones, like Addy - "Need you here. I want you to know you were literally my right hand. I can't do this without you."

Kessinger searched the internet on topics related to Amber Frey (*the mistress of Scott Peterson; he murdered his wife and unborn child*). Her searches included Frey's book deal, her net worth and "did people hate Amber Frey"
