3. Narrative

On 11/13/22 at about 1200 hours I responded to 1122 King Rd for the report of a unresponsive subject. Upon my arrival I noticed there were several college aged subjects out front of the address. I was directed to use police caution tape to cordon off the crime scene. As I was working around the residence I noticed the back door was open and there were footprints in the snow coming from the back door on the back porch. Ofc. Smith took photos of these prints with a measuring tape. He watched the back yard area to make sure no one else came in to the area. I noticed there were a few foot prints that left toward the west of the back yard. This portion of the back yard is connected to two other residences, 1118 King Rd and 1126 King Rd, both directly to the west. The foot prints appear to lead west toward King Rd. between the residences, but I was unable to see where the foot prints went after the yards connected due to the amount of rock landscaping. I also was unable to discern how old these prints were. There had not been recent snow fall.

With Sgt. Gunderson, I entered the residence to continue taking photos of the scene. I entered through the bottom floor main door, on the north side. I took photographs of the rooms and living areas of the residence. The photos were downloaded onto a CD and booked into evidence. The photos were labeled in this report with a brief description of each photo.

As I was down the road of the address near the King Rd and Queen Rd intersection, I was approached by a college aged male who identified himself as J[REDACTED]. He informed me he lived at [REDACTED] King Rd apartment [REDACTED]. He stated his [REDACTED], lived upstairs at 1122 King Rd and they share a dog that was there

currently. J [REDACTED] did not appear to have obvious wounds on his hands, as I would assume the suspect possibly would. Ofc. Nunes was interviewing subjects about the situation. I asked J [REDACTED] if he would wait inside Ofc. Nunes' police car so we could talk with him. He agreed to. I informed Sgt. Gunderson of the circumstance involving J [REDACTED]. J [REDACTED] later responded to the police department to be interviewed and then picked up the dog from the Moscow Humane Society Shelter.

I continued to canvas the area and speak with neighbors at [REDACTED] [REDACTED] and [REDACTED] Queen Rd. who stated they did not hear or see anything relevant. I spoke with subjects at [REDACTED] King Rd. One resident, D [REDACTED] I [REDACTED], stated she was walking home from the Corner Club at about 0300 hours and thought she could hear music or some type of noise, but she couldn't give any clarifying information more than that due to her level of intoxication that night.

I spoke with subjects at [REDACTED] King Rd. The majority of them stated they were out drinking at the Corner Club and got a ride back to their place at about 0130 hours and went to sleep about 0200. They did not hear anything out of the ordinary. [REDACTED] King Rd [REDACTED] resident, B [REDACTED] E [REDACTED], stated at about 0400 hours he heard a barking dog coming from the east of his residence. He believed it was the dog at 1122 King Rd. as he thought that was the only dog in the area. He stated the dog sounded like it was outside and was barking for about 45 minutes until he believed someone must have let it inside at 0445 when it stopped. B [REDACTED] stated he had a female with him in bed at the time who also heard the dog barking at this time.

I spoke with the residents at [REDACTED] King Rd. F [REDACTED] C [REDACTED] informed me they had a camera facing the west of the address that they believed captures a portion of the road. They first provided me with the sim card out of the camera, however they could not get it to work and neither could I. They gave me the user name and password to the camera. I informed Detective Mowery of the information and they gave me permission to access the camera footage and record the necessary surveillance video.

I cleared the scene at about 1749 Hours.
