6. Narrative

On 11/13/22, at approximately 1156 hours, MPD officers responded to an unconscious call. The RP, later identified as B [REDACTED] F [REDACTED], reported her roommate was passed out, not conscious, and not breathing. As I was preparing to leave the station, Ofc. Nunes, who was already on scene, advised of a likely homicide and asked for additional units. While I was enroute, Ofc. Nunes advised he had located two additional victims. The victims were later identified as Kaylee J. Goncalves, Ethan J. Chapin, Xana A. Kernodle, and Madison M. Mogen. Moscow EMS was asked to stage and not respond to the scene unless requested.

Upon arrival, I saw H [REDACTED] J [REDACTED] crouching near the entrance to 1122 King Rd. J [REDACTED] was in obvious emotional distress. I entered through the 1st floor door (which faces north towards the parking lot). I announced myself as a Moscow Police Officer and heard Ofc. Nunes and Warner respond from upstairs. When I got to the second floor, I saw a female covered in blood in the bedroom on the NW side of the second floor. I believe this female to be Xana. I looked inside the bedroom Xana was laying and it was obvious an intense struggle had occurred. Xana was obviously deceased. There was blood smeared on various items in the room and all over the floor. There was blood cast-off on the walls in various places, including above Xana's body. Xana was on her back on the floor in the center of the room with her head towards the west. Xana was in her underwear and a long sleeved grey shirt. Both her shirt and underwear were covered in blood. Xana's face and body was covered in dried blood. I could see what appeared to be defensive knife wounds on Xana's hands. There was a deep gash on Xana's left

hand between her pointer finger and thumb. A partially covered male was on the bed and also obviously deceased. I believe this male to be Ethan. The midsection of Ethan's body was covered with a blanket. Ethan's head wasn't visible and appeared to be between the bed and the south wall. There was some blood cast-off and what appeared to be arterial blood spray above where Ethan's head was located.

I proceeded upstairs to the third floor where I met Ofc. Nunes and Warner. Ofc. Nunes and Warner advised the residence was clear of any additional people. There was a dog belonging to Kaylee in the third floor west bedroom, which has access to a third floor deck (the deck has no exterior access to the ground level). I asked Cpl. Snyder to cordon off the area and Ofc. Nunes to start identifying the subjects that were on scene when he arrived. I asked Ofc. Warner to start a crime scene log at the front entrance. Once Ofc. Smith arrived on scene, I asked him to stand guard at the kitchen sliding door, which I later learned was ajar upon our arrival.

On the third floor, I went to the SE bedroom where Ofc. Nunes and Warner advised they found two females, whom I believe to be Kaylee and Madison. Both females were obviously deceased. I observed Kaylee lying on the north side of the bed and Madison lying on the south side of the bed with their heads towards the east. Kaylee and Madison were covered by a pink blanket which was covered in blood. There was a large pool of blood near Kaylee's midsection. There was blood cast-off on the east and north walls above Kaylee and Madison. Madison appeared to be laying up against Kaylee. Madison had what appeared to be wounds to her forearm and hands. Madison had a gash under her right eye which appeared to go from the corner of her eye to her nose. Kaylee was unrecognizable as her facial structure was extremely damaged.

I asked Ofc. Nunes to close the door to the bedroom so the dog did not try to disturb the scene. Other than that action, MPD Patrol officers left the scene as it was found. I was later confirmed with Ofc. Nunes that no EMS personnel entered the prior to my arrival.

I contacted Capt. Berrett and advised him of the situation. Capt. Berrett said he would activate detectives and get more resources enroute. Once Det. Sgt. Lawrence arrived on scene, he requested one of the responding patrol officers begin writing a search warrant, which was assigned to Ofc. Nunes. Cpl. Snyder was assigned to take initial photos of the scene while Ofc. Smith and Warner remained as security at both entrances. I collected the dog from the third floor and took it outside. LCSO Dep. Olson transported the dog to the humane society on my behalf.
