Initial Interviews

Case # 22-M09903
Date: 11/15/2022

On November 13, 2022, I was directed to interview potential witnesses in regards to the incidents at 1122 King Road. The following interviews were conducted at the Moscow Police Department.

Interview 1:

D [REDACTED] M [REDACTED] DOB: [REDACTED]/2003 PH: [REDACTED]
Address: 1122 King Rd

On 11/13/2022 D [REDACTED] M [REDACTED] was interviewed in regard to the homicide investigation at 1122 King Road. D [REDACTED] said she was a resident of the house where the incident occurred. D [REDACTED] said she was at a [REDACTED] party, at around 1030 hours on 11/12/2022, where she was drinking. D [REDACTED] said she went to "[REDACTED] house". D [REDACTED] said she believed she arrived home between 0030 hours and 0100 hours on 11/13/2022. D [REDACTED] said she thought B [REDACTED] arrived home at around 20 minutes after she arrived.

D [REDACTED] said she believed Maddie and Kaylee arrived home at around 0130 or 0200 hours on 11/13/2022. D [REDACTED] said up to this nothing weird had happened during the night. D [REDACTED] said she and her friend "I [REDACTED] (?)" came home, followed by B [REDACTED] from [REDACTED]. D [REDACTED] said I [REDACTED] lived at the [REDACTED] house and B [REDACTED] was her roommate at the residence. D [REDACTED] said when Maddie Mogen and Kaylee Gonclaves came home from the corner club at the same time, and everyone went to bed.

D [REDACTED] was asked about the layout of her house. D [REDACTED] said Kaylee's room was directly above her room. D [REDACTED] said she lived on the 2nd floor and Kaylee lived on the 3rd floor. D [REDACTED] said Kaylee and Maddie both live upstairs on the 3rd floor in separate rooms. D [REDACTED] said Xana lived closest to the bathroom on the 2nd floor and B [REDACTED] lived on the first floor.

When asked about Murphy, D [REDACTED] said it was a dog owned in common between Kaylee and her ex-boyfriend J [REDACTED]. D [REDACTED] said there were no apparent issues between Kaylee and J [REDACTED]. D [REDACTED] said Maddie had a boyfriend named J [REDACTED] S [REDACTED] who was

in Boise at the time of the incident. D█████ indicated Xana was dating Ethan Chapin who was in the room with her at the time of the incident. D█████ did not know of anyone who would want to hurt Ethan, when she was asked. D█████ was asked if she saw any cars in the area that should not be there. D█████ said "No I was not really looking at that."

D█████ said she woke up at around 0400 hours on 11/13/2022, where she could here Kaylee and Murphy, the dog, dancing. D█████ said she knew it was Kaylee because she recognized her voice and could hear Murphy barking. D█████ said she heard Kaylee go upstairs and say "There is someone here." D█████ said thought she heard Kaylee run back down the stairs. D█████ said Kaylee sounded scared when she made this statement.

D█████ said at this time she jumped up locked the door because she did not know what else to do. D█████ said she called out Kaylee's name and did not indicate if she got a response. D█████ said she then tried to call Kaylee, Xana and Maddie on their phones. D█████ was asked if she saw anyone come downstairs or heard anything. D█████ said, "No, I don't even know how they got in. We're usually pretty good about locking doors and never had problems before. I was just really random."

When asked again about the series of events, D█████ said she opened the door when she cried out to Kaylee, then closed the door because she was scared. D█████ said she then opened the door again and heard who she thought was Kaylee, but could have been Xana, crying in the bathroom. D█████ said she then heard a man's voice say "It's OK I'm gonna help you." D█████ said it was weird because the statement was not in a nice way and the voice was one she had never heard before.

D█████ said she called out to Kaylee again and there was no crying after and she did not know what happened after that. D█████ said she opened the door again and "the guy" is right there. D█████ described the male as approximately her height (5'10") or a few inches taller, not skinny but athletic build. D█████ said the suspect was wearing all black with masks that covered just his forehead and goes around his face. D█████ showed with her hands the mask exposed his nose but covered the mouth area.

D█████ said she believed the suspect was white but did not remember eyebrow color or what his eyes looked like. D█████ said when she saw the suspect, he saw her and just left. D█████ said she believed he was holding something near his stomach or belt line. D█████ used both hands to point straight out from her abdomen. D█████ then moved her hands apart and back together to simulate a bulge. D█████ said this area was black in color and she thought now maybe it was a gun. D█████ said the unknown object had an arrow shape. D█████ seemed really unsure and said she was tired during the event.

D█████ was asked how long she believed it was from the time Kaylee said "Someone is here", to when she saw the suspect. D█████ said she thought it was about 10 or 20 minutes. D█████ went on to say she was "in and out of it" and she did not fully remember the incident. D█████ was asked where the suspect was at in the residence when D█████ saw him. D█████ said the suspect was between her bedroom door and the kitchen. D█████ said she remembered watching the suspect go out the kitchen door and leave. D█████ said at this time she closed her door and locked it as fast as she could. D█████ said the suspect did not walk toward her or say anything.

D█████ said once the suspect left she immediately called B█████. D█████ said

B [REDACTED] informed her she heard a sound that sounded like a firework. D [REDACTED] then said she told E [REDACTED] she called everyone and they are not answering. D [REDACTED] said she was in and out of it and believed everyone was just asleep. D [REDACTED] said she then went to E [REDACTED] room locked the door and went to bed. D [REDACTED] said she woke up at around 1100 or 1200 hours and called her roommates and no one answered. D [REDACTED] said she called H [REDACTED]. H [REDACTED] came to the residence, went upstairs and told D [REDACTED] they needed to call law enforcement immediately. D [REDACTED] was asked if there was anything else she wanted to share. D [REDACTED] said the noise E [REDACTED] described the noise as a "loud boom", but D [REDACTED] did not hear it.

D [REDACTED] was asked if any of her roommates shared any weird experiences in the last couple weeks, or calls or texts. D [REDACTED] said "No, it's been all normal. Nothing weird at all. Nothing really weird happens in Moscow usually." When asked if there were any altercations at the [REDACTED] party. D [REDACTED] said no everything was normal. D [REDACTED] mentioned again she was with D [REDACTED] and Xana at the party. D [REDACTED] was asked if anyone was having sexual relations with anyone they shouldn't be. D [REDACTED] said no.

D [REDACTED] brought up an incident which occurred about a month prior. D [REDACTED] said she and E [REDACTED] remembered Kaylee saw a shadow while she was taking Murphy at side. D [REDACTED] said Kaylee also mentioned when she was at [REDACTED] 2 or 3 weeks prior, an individual was following her. D [REDACTED] also said she arrived home one time and the door to the residence at 1122 King Road was found open. D [REDACTED] said she did not believe the slider door was locked the night 11/12/22. D [REDACTED] said she hear Murphy barking a lot around 0400 hours 11/13/22 when Kaylee went upstairs. D [REDACTED] said she heard Murphy go outside barking as well. D [REDACTED] was unsure if Murphy would chase a suspect outside. D [REDACTED] said she did not remember if the suspect who ran left the slider door open.

Interview 2:

H [REDACTED] said around 1200 hours on 11/13/2022, D [REDACTED] called E [REDACTED] (H [REDACTED] Girlfriend). D [REDACTED] told E [REDACTED] she thought something "was not right in her house" D [REDACTED] also told E [REDACTED] she heard or saw a man in her house the night prior. D [REDACTED] asked E [REDACTED] and H [REDACTED] to come over and make sure everything was OK because she locked herself in E [REDACTED] room. H [REDACTED] said he was the first person to get to the residence. H [REDACTED] said he entered the code to the front door where E [REDACTED] and D [REDACTED] were in E [REDACTED] room on the first floor. D [REDACTED] and E [REDACTED] were telling H [REDACTED] they did not know what was going on.

H [REDACTED] said he went up the stairs and immediately went into Xana's room. H [REDACTED] said this was the only room he went into. H [REDACTED] said when he approached the door it was only partially open. H [REDACTED] said when he opened it, he saw Xana and Ethan. H [REDACTED] said he initially did not realize all the blood was dried blood in the room. H [REDACTED] said he thought at first they had been drunk and left a mess. H [REDACTED] said when he stood there for a moment he began to realize what he was seeing. H [REDACTED] said E [REDACTED] and D [REDACTED] were uncontrollably crying. H [REDACTED] said he told them to get out of the house and call law enforcement.

H [REDACTED] said he then went to the kitchen and grabbed a knife from the drawer. H [REDACTED] said he then went into the room and checked the closet to make sure there was not anyone else in the room. H [REDACTED] said he checked for a pulse on both Xana and Ethan. H [REDACTED] said both of the bodies had rigor mortis and were cold with no breath or pulse. H [REDACTED] said he believed the two had been deceased for a while.

H [redacted] said he believed he left the knife on the folding table in the living room. H [redacted] said E [redacted], J [redacted] and I [redacted] started to enter the house and come up the stairs. H [redacted] told them to get out of the residence. H [redacted] said this was about the time Moscow PD arrived on scene. H [redacted] said the officer told him to stay where he was at. H [redacted] said he did not know if anyone else was upstairs as he had not gone anywhere else in the house. H [redacted] said he had trouble comprehending what he was seeing.

H [redacted] said he was not at the [redacted] party the night prior. H [redacted] said he and Ethan were texting the night prior (11/12/22) by phone. H [redacted] said Ethan wanted him to come over but H [redacted] chose not to. H [redacted] said he knew Ethan since Fall of 2021. H [redacted] said he was in [redacted] and Ethan was a member of [redacted]. H [redacted] indicated J [redacted] and E [redacted] were in the same sorority and were roommates. H [redacted] said I [redacted] who was also present was in the fraternity [redacted] and was currently dating J [redacted]. H [redacted] said he and I [redacted] stayed at J [redacted] apartment with E [redacted] and J [redacted] the night of 11/12/22. H [redacted] was asked when was the last time he was at 1122 King Road.

H [redacted] indicated he was last at the residence on 11/12/22 where he was "pre-gaming for the vandals football game." H [redacted] said he got to the residence at around 1200 hours or 1300 hours and left at about 1430 hours to go to a different party. H [redacted] said the last time E [redacted] was at 1122 King Road was Friday 11/11/22. H [redacted] did not know of anyone who had issues with E [redacted] and Xana dating. H [redacted] estimated Xana and Ethan were dating for 8 months. H [redacted] said he knew Xana very well through his girlfriend E [redacted]. H [redacted] said he was not very familiar with Maddie or Kaylee. H [redacted] allowed pictures to be taken of his phone of the conversations between him and Ethan.

Interview 3

J [redacted] said she text E [redacted] at 1120 hours, on the morning of 11/13/22. J [redacted] asked E [redacted] if she was awake. J [redacted] said E [redacted] called her back at 1149 hours. E [redacted] told J [redacted] she and D [redacted] were in E [redacted] room. J [redacted] said E [redacted] was freaked out because her roommates were not answering the phone. J [redacted] said she heard D [redacted] on the phone in the background saying "I saw something." J [redacted] said E [redacted] asked her to come over to 1122 King Road and pick her up. J [redacted] said E [redacted] text her while she was driving there, and said E [redacted] and H [redacted] were on the way as well. J [redacted] said as she arrived MPD units were arriving as well. J [redacted] said she did not go to the [redacted] party but went to a different one instead. J [redacted] said E [redacted] and D [redacted] came to this other party after she left [redacted]. J [redacted] estimated D [redacted] left her party at 0030 hours and E [redacted] left her party at about 0100 hours on 11/13/2022.

J [redacted] said she was in [redacted] with D [redacted], I [redacted], E [redacted] and Xana. J [redacted] said Xana and Maddie were both in [redacted] but the dropped out and Kaylee was in [redacted] but dropped as well. J [redacted] suspected they girls dropped their respective sororities because of issues with other girls in the houses. J [redacted] specifically cited girls on the "executive board" who tell other members what to do. J [redacted] suspected this was what they did not like. J [redacted] confirmed she, I [redacted], E [redacted] and D [redacted] were still active members in [redacted]. J [redacted] said the girls who were still active members of the sorority who chose to not live in the house did so because of money issues. J [redacted] said Maddie was E [redacted] Big Sister in the sorority house.

J [REDACTED] said she knew Kaylee saw a dark figure staring at her from the tree line when she took her dog Murphy out to pee. J [REDACTED] said this occurred about a month ago at 1122 King Road. J [REDACTED] said there has been light hearted talk and jokes made about a stalker in the past. J [REDACTED] said all the girls were slightly nervous about it being a fact though. J [REDACTED] did not indicate any social media issues or issues between the girls who lived together. J [REDACTED] said there was no issue with girls from the [REDACTED] sorority and the residence at 1122 King Road. J [REDACTED] said the front door had issues with locking and sometimes it could be opened without a code. J [REDACTED] said she did know the code to the front door. J [REDACTED] said she was unsure if the residence kept the back-sliding door locked regularly.

Interview 4

I [REDACTED] said he did not go to the [REDACTED] Party. I [REDACTED] said he went to sleep at 2000 hours 11/12/22, at J [REDACTED] apartment on Taylor Ave. I [REDACTED] said he woke up around 0200 or 0300 hours I [REDACTED] said he J [REDACTED] and E [REDACTED] were up talking in the living room of the apartment until about 0500 hours on 11/13/22. I [REDACTED] indicated H [REDACTED] was present but not awake during this time. I [REDACTED] said I [REDACTED] said they all went to bed at this time and woke up again around what he thought was 0900 hours.

I [REDACTED] said H [REDACTED] and E [REDACTED] came into the room where he and J [REDACTED] were. I [REDACTED] said D [REDACTED] had called E [REDACTED] around 1000 hours, and sounded scared. I [REDACTED] said D [REDACTED] told E [REDACTED] someone had been in her house last night. I [REDACTED] said I [REDACTED] and E [REDACTED] ran down stairs and locked themselves in a room. I [REDACTED] said, D [REDACTED] informed them she did this because of her seeing someone in the house and D [REDACTED] could only see his nose and his chin. I [REDACTED] said D [REDACTED] was freaking out and wanted them to come over to 1122 King Road.

I [REDACTED] said he walked with E [REDACTED], J [REDACTED] to 1122 King road from J [REDACTED] apartment on Taylor Ave. I [REDACTED] said D [REDACTED] and E [REDACTED] walked out of the house crying. I [REDACTED] said H [REDACTED] arrived to the residence first, because he left before them. I [REDACTED] said he went into the downstairs door and H [REDACTED] told him not to come up the stairs. I [REDACTED] said he did not know Ethan very well. I [REDACTED] said he did not recall any talk between Xana and J [REDACTED] about boy issues. I [REDACTED] said he did not see anything on social media. I [REDACTED] recalled an incident from about a month prior, where D [REDACTED] said there was a guy stalking her. I [REDACTED] said he did not hear anything from the night prior.
