Initial Interviews

On November 13, 2022, I was directed to interview potential witnesses in regards to the incidents at 1122 King Road. The following interviews were conducted at the Moscow Police Department.

Interview 1:

DOB: /2003 PH: Address: 1122 King Rd

On 11/13/2022 Death Market was interviewed in regard to the homicide investigation at 1122 King Road. Death said she was a resident of the house where the incident occurred. Death said she was at a party, at around 1030 hours on 11/12/2022, where she was drinking. Death said she went to "house". Death said she believed she arrived home between 0030 hours and 0100 hours on 11/13/2022. Death said she thought Beauty arrived home at around 20 minutes after she arrived.

Description said she believed Maddie and Kaylee arrived home at around 0130 or 0200 hours on 11/13/2022. Description said up to this nothing weird had happened during the night. Description said she and her friend "I (?)" came home, followed by Brown and Brown was her roommate at the residence. Description said when Maddie Mogen and Kaylee Gonclaves came home from the corner club at the same time, and everyone went to bed.

was asked about the layout of her house. Descriptions said Kaylee's room was directly above her room. Descriptions said she lived on the 2nd floor and Kaylee lived on the 3rd floor. Descriptions said Kaylee and Maddie both live upstairs on the 3rd floor in separate rooms. Descriptions said Xana lived closest to the bathroom on the 2nd floor and Person lived on the first floor.

When asked about Murphy, Described it was a dog owned in common between Kaylee and her ex-boyfriend Jee. I said there were no apparent issues between Kaylee and Jee. Said Maddie had a boyfriend named Jee Switch who was

in Boise at the time of the incident. Description indicated Xana was dating Ethan Chapin who was in the room with her at the time of the incident. Description did not know of anyone who would want to hurt Ethan, when she was asked. Description was asked if she saw any cars in the area that should not be there. Description and "No I was not really looking at that."

Description said she woke up at around 0400 hours on 11/13/2022, where she could here Kaylee and Murphy, the dog, dancing. Description said she knew it was Kaylee because she recognized her voice and could hear Murphy barking. Description said she heard Kaylee go upstairs and say "There is someone here." Description said thought she heard Kaylee run back down the stairs. Description said Kaylee sounded scared when she made this statement.

said at this time she jumped up locked the door because she did not know what else to do. December said she called out Kaylee's name and did not indicate if she got a response. December said she then tried to call Kaylee, Xana and Maddie on their phones. December said she saw anyone come downstairs or heard anything. December said, "No, I don't even know how they got in. We're usually pretty good about locking doors and never had problems before. I was just really random."

When asked again about the series of events, Descriptions said she opened the door when she cried out to Kaylee, then closed the door because she was scared. Descriptions said she then opened the door again and heard who she thought was Kaylee, but could have been Xana, crying in the bathroom. Descriptions said she then heard a man's voice say "It's OK I'm gonna help you." Descriptions said it was weird because the statement was not in a nice way and the voice was one she had never heard before.

said she called out to Kaylee again and there was no crying after and she did not know what happened after that. Described the opened the door again and "the guy" is right there. Described the male as approximately her height (5'10") or a few inches taller, not skinny but athletic build. Described the suspect was wearing all black with masks that covered just his forehead and goes around his face. Described the mask exposed his nose but covered the mouth area.

said she believed the suspect was white but did not remember eyebrow color or what his eyes looked like. I said when she saw the suspect, he saw her and just left. I said she believed he was holding something near his stomach or belt line. I used both hands to point straight out from her abdomen. Then moved her hands apart and back together to simulate a bulge. I said this area was black in color and she thought now maybe it was a gun. I said the unknown object had an arrow shape. I seemed really unsure and said she was tired during the event.

was asked how long she believed it was from the time Kaylee said "Someone is here", to when she saw the suspect. Description said she thought it was about 10 or 20 minutes. Description went on to say she was "in and out of it" and she did not fully remember the incident. Description was asked where the suspect was at in the residence when Description said the suspect was between her bedroom door and the kitchen. Description said she remembered watching the suspect go out the kitchen door and leave. Description said at this time she closed her door and locked it as fast as she could. Description said the suspect did not walk toward her or say anything.

said once the suspect left she immediately called B said

informed her she heard a sound that sounded like a firework. Described her said she told B she called everyone and they are not answering. It said she was in and out of it and believed everyone was just asleep. Described said she then went to B room locked the door and went to bed. Described said she woke up at around 1100 or 1200 hours and called her roommates and no one answered. Described the called H came to the residence, went upstairs and told Described to call law enforcement immediately. Described the noise B described the noise as a "loud boom", but Described the noise B did not hear it.

Description was asked if any of her roommates shared any weird experiences in the last couple weeks, or calls or texts. Description said "No, it's been all normal. Nothing weird at all. Nothing really weird happens in Moscow usually." When asked if there were any altercations at the party. Description and Xana at the party. Description was normal. Description mentioned again she was with Description and Xana at the party. Description was asked if anyone was having sexual relations with anyone they shouldn't be.

brought up an incident which occurred about a month prior. I said she and B remembered Kaylee saw a shadow while the was taking Murphy at side. D said Kaylee also mentioned when she was at 2 or 3 weeks prior, an individual was following her. D also said she arrived home one time and the door to the residence at 1122 King Road was found open. D said she did not believe the slider door was locked the night 11/12/22. D said she hear Murphy barking a lot around 0400 hours 11/13/22 when Kaylee went upstairs. D said she heard Murphy go outside barking as well. D was unsure if Murphy would chase a suspect outside. D said she did not remember if the suspect who ran left the slider door open.

Interview 2:

H DOB: /1999 PH: Address:

Figure 3 said around 1200 hours on 11/13/2022, Described Eq. (House Girlfriend). Described told Eq. she thought something "was not right in her house" also told Eq. she heard or saw a man in her house the night prior. Described and House to come over and make sure everything was OK because she locked herself in Born from. How said he was the first person to get to the residence. How said he entered the code to the front door where Pand Described House in Born from on the first floor. Described House were telling House they did not know what was going on.

said he went up the stairs and immediately went into Xana's room. He said this was the only room he went into. He said when he approached the door it was only partially open. He said when he opened it, he saw Xana and Ethan. He said he initially did not realize all the blood was dried blood in the room. He said he thought at first they had been drunk and left a mess. He said when he stood there for a moment he began to realize what he was seeing. He said Be and I were uncontrollably crying. He said he told them to get out of the house and call law enforcement.

said he then went to the kitchen and grabbed a knife from the drawer.

He said he then went into the room and checked the closet to make sure there was not anyone else in the room. He said he checked for a pulse on both Xana and Ethan. He said both of the bodies had rigor mortis and were cold with no breath or pulse. He said he believed the two had been deceased for a while.

said he believed he left the knife on the folding table in the living room. He said E , J and I started to enter the house and come up the stairs. He told them to get out of the residence. He said this was about the time Moscow PD arrived on scene. He said the officer told him to stay where he was at. He said he did not know if anyone else was upstairs as he had not gone anywhere else in the house. He said he had trouble comprehending what he was seeing.

How said he was not at the party the night prior. How said he and Ethan were texting the night prior (11/12/22) by phone. How said Ethan wanted him to come over but How chose not to. How said he knew Ethan since Fall of 2021. How said he was in and Ethan was a member of ... How indicated John and Ethan was a member of and Ethan was a member of ... How said Low who was also present was in the fraternity and was currently dating John said he and Low stayed at John apartment with Edward and John the night of 11/12/22. How was asked when was the last time he was at 1122 King Road.

How indicated he was last at the residence on 11/12/22 where he was "pre-gaming for the vandals football game." How said he got to the residence at around 1200 hours or 1300 hours and left at about 1430 hours to go to a different party. How said the last time E was at 1122 King Road was Friday 11/11/22. How did not know of anyone who had issues with E and Xana dating. How estimated Xana and Ethan were dating for 8 months. How said he knew Xana very well through his girlfriend E allowed pictures to be taken of his phone of the conversations between him and Ethan.

Interview 3

J M DOB: 2003 PH: Address:

said she text B at 1120 hours, on the morning of 11/13/22. Jasked B if she was awake. Journal Said B called her back at 1149 hours. B told Journal She and D were in B common. Journal Said B was freaked out because her roommates were not answering the phone. Journal Said B asked her to come over to 1122 King Road and pick her up. Journal Said B text her while she was driving there, and said E and H were on the way as well. Journal Said as she arrived MPD units were arriving as well. Journal Said B said She did not go to the party but went to a different one instead. Journal Said B said She and D said B said She arrived MPD units were arriving as well. Journal Said B said B

said she was in with D , I , B and Xana. J said Xana and Maddie were both in but dropped as well. J suspected they girls dropped their respective sororities because of issues with other girls in the houses. J specifically cited girls on the "executive board" who tell other members what to do. J suspected this was what they did not like. J confirmed she, I , B and D were still active members in who were still active members of the sorority who chose to not live in the house did so because of money issues. J said Maddie was B Big Sister in the sorority house.

J said she knew Kaylee saw a dark figure staring at her from the tree line
when she took her dog Murphy out to pee. J said this occurred about a month
ago at 1122 King Road. J said there has been light hearted talk and jokes
made about a stalker in the past. J said all the girls were slightly nervous
about it being a fact though. J did not indicate any social media issues or
issues between the girls who lived together. J said there was no issue with
girls from the sorority and the residence at 1122 King Road. J
said the front door had issues with locking and sometimes it could be opened
without a code. J said she did know the code to the front door. J said
she was unsure if the residence kept the back-sliding door locked regularly.

Interview 4

L E /2002 PH: Address:

said he did not go to the party. I said he went to sleep at 2000 hours 11/12/22, at Jack apartment on Taylor Ave. I said he woke up around 0200 or 0300 hours I said he Jack and E were up talking in the living room of the apartment until about 0500 hours on 11/13/22. I indicated H was present but not awake during this time. I said I said they all went to bed at this time and woke up again around what he thought was 0900 hours.

said How and E came into the room where he and J were. I said D had called E around 1000 hours, and sounded scared. I said D told E someone had been in her house last night. I said D and B ran down stairs and locked themselves in a room. I said, D informed them she did this because of her seeing someone in the house and D could only see his nose and his chin. I said D was freaking out and wanted them to come over to 1122 King Road.

, J to 1122 King road from J said he walked with E apartment on Taylor Ave. I said D and B walked out of the house crying. arrived to the residence first, because he left before them. said H said he went into the downstairs door and H told him not to come up the stairs. I said he did not know Ethan very well. I said he did not recall any talk between Xana and J about boy issues. I said he did not see anything on social media. I recalled an incident from about a month prior, where D said there was a guy stalking her. I said he did not hear anything from the night prior.

My interviews were video recorded and have been uploaded to case file.
