3. Narrative

On November 23, 2022, at approximately 2039 hours, M [REDACTED] M [REDACTED] came to the Moscow Police Department to be interviewed about her presence in the area of 1122 King Road during the early morning hours of November 13, 2022. M [REDACTED] was identified as being in the area through records obtained from Doordash via a search warrant and was confirmed as being in the area based off a Google Geofence warrant which was obtained as a result of this investigation. I was accompanied by FBI Special Agent Alix Skelton during this interview.

M [REDACTED] told me she worked for twelve to eighteen hours on the night November 12th to the 13th and received three orders in the King Road/Queen Road area. Two of the orders were at the [REDACTED] Queen Road apartment complex which is immediately to the east of 1122 King Road. M [REDACTED] said the delivery at 1122 King Road was her final order for the evening. M [REDACTED] said she could not find the 1122 Kind Road address as the address number was hidden by the porch light which caused her to remain in the area for approximately fifteen minutes. M [REDACTED] also stated her Google Maps told her to go to the parking lot immediately behind 1122 King Road.

M [REDACTED] stated she initially parked in the front of 1122 King Road and could see a female in the top left window (the third story bathroom). M [REDACTED] said she saw the same female a couple more times in the same window and she would duck down when M [REDACTED] looked at her.

M [REDACTED] then said she drove to the back parking lot behind 1122 King Road and parked. She stated she could see the back "courtyard" area behind the house and

noticed all of the lights were on. M█████ stated her map told her to walk into the back of the house but she did not feel comfortable doing so because there was no path. M█████ said she started to walk down the road which runs north/south immediately to the east of the residence. M█████ stated a tan sedan drove next to her while she was walking.

M█████ said there was one male driver and noticed "he did not look at me". She said he looked "completely zoned" and just drove by her. M█████ later stated the driver was white with blonde or red spikey hair. M█████ also noticed the dome light in the car was on when it went by and later told me the male was wearing a light-colored collared shirt.

M█████ stated she walked back up to her car and drove back to the front of 1122 King Road, at which point she saw the address numbers. M█████ said she placed the order at the front door, took a picture, and then left at approximately 0400 hours.

During the time M█████ was in the area of the King Road Residence, the white Elantra can be seen via the █████ King Road Camera driving back and forth on Walenta Drive and then enter the King Road/Queen Road loop at approximately 0356 hours. At the point M█████ pulled into the front parking lot before she dropped the order off, the white Elantra pulled in behind M█████ vehicle (a gray Subaru Forester) and then exited the King Road at approximately 0358 hours. M█████ did not mention seeing the white Elantra behind her at any time.

I continued to question M█████ about her time near the residence. She told me she walked down Queen Road at one point with her flashlight out. M█████ can be seen doing so on the footage from █████ King Road. M█████ also continued to tell me the female she saw in the upstairs bathroom window would duck down when M█████ looked at her. M█████ described her as having long brown hair. M█████ stated she could not identify the girl as one of the victims.

Approximately thirty minutes into the interview, SA Skelton requested M█████ take part in a cognitive interview. M█████ agreed and SA Skelton began the cognitive interview. During this interview, M█████ confirmed much of the information she already told us. M█████ was able to remember she had her dog with her during one of her walks in the area but did not clarify much more in the ways of the details of the evening. We thanked M█████ for her cooperation, offered any support she may need, and concluded our interview.

Subsequent investigation of video footage and cellular data showed the "tan sedan" M█████ saw was likely a light-colored SUV which left the area. Moreover, it does not appear M█████ saw the white Elantra at any point during her time near the residence.
