3. Narrative

On Monday, September 16, 2024, I spoke to ██████████. ██████████ was an inmate at the Latah County Jail at the time and had been housed next to Kohberger since August of 2024 until Kohberger's transport to Ada County on September 15, 2024. I was made aware by Det. Vargas that ██████████ spoke about Kohberger while on a phone call with his mother.

I responded to the Latah County Jail and spoke to ██████████. I began by asking ██████████ what he thought of Kohberger having had to live next to him. ██████████ told me Kohberger was highly intelligent and polite for the most part. ██████████ told me Kohberger would often question him about his past criminal offenses and why he was in the maximum-security wing of the jail. I asked ██████████ what he thought of Kohberger's intelligence. ██████████ stated Kohberger was the smartest person he had encountered while in confinement.

██████████ told me Kohberger quickly became annoying because of some of his habits. He told me Kohberger would wash his hands dozens of times each day and would spend 45 minutes to an hour in the shower. I asked ██████████ if Kohberger slept at night. He told me Kohberger would be awake almost all night and would only take a nap during the day. ██████████ said he could hear Kohberger moving around all night which also annoyed ██████████.

I asked ██████████ if Kohberger ever lost his temper. He told me on one occasion Kohberger was video chatting with his mother (which ██████████ said he did for hours each day) while ██████████ was watching sports. ██████████ said "you suck" to one of the players on the team at which point Kohberger immediately got up and put his face

to the bars and aggressively asked if [REDACTED] was talking about him or his mother. [REDACTED] said this was the only time Kohberger lost his temper.

I asked [REDACTED] if Kohberger had mentioned anything about the crimes he was charged with. [REDACTED] said Kohberger did not mention his alleged offenses at all. [REDACTED] also told me Kohberger was excited to move to Ada County. [REDACTED] stated he had served time at Ada County and noted he did not think Kohberger would like to be there.

I thanked [REDACTED] for speaking with me and advised him to notify the Latah County Detention Deputies if he remembered anything else he wished to tell me.
