3. Narrative

On November 13, 2022 at approximately 1253 hours, I arrived on scene at 1122 King Rd. and spoke with Sgt. Gunderson and Sgt. Lawrence who gave me a brief overview of the information gathered at that time. Sgt. Lawrence informed me the Idaho State Police were going to assist in the investigation and were organizing to respond to the scene. Sgt. Lawrence responded to the police department to begin interviews. I remained on scene on the perimeter awaiting further information.

Approximately one hour later, a male approached the scene and began speaking with Sgt. Gunderson. The male was identified as Jack Karry, I overheard Jack State his daughter lived in the 1122 King Rd. and he had been trying to get in touch with her but was unsuccessful. It was also learned Jack I daughter Jack R. Karry, was nearby the scene. I asked Jack I if he and Jack Could come to the police department to speak with me. Jack I agreed and I returned to the police department. I contacted Sgt. Lawrence at the police department and asked if he had the names of the victims. Sgt. Lawrence stated he did and gave me the list. I saw one of the victim's names was Xana A. Kernodel. I then met with Jack and Jack I in the interview room off of the police department lobby. Once in the room, I activated the audio and video recording equipment.

I asked Jacked and Jacked for their information and they both handed me their Arizona driver's licenses. After writing down their information, I asked Jacked what the name of his other daughter was. Jacked told me her name was Xana. I then informed Jacked and Jacked that Xana was identified as one of the victims and that she was deceased. Both J and J became very upset and were crying heavily.

I asked Jacoba and Jacoba when the last time they communicated with Xana was. Jacoba stated she texted with Xana on 11/11/22 at approximately 1700 hours. Jacoba said the text messages were brief and were not of any substance. Jacoba said he texted Xana on 11/11/22 at around 1540 hours and she responded stating she was at work. Jacoba then told me he last spoke with Xana on the phone on 11/11/22 at approximately 2140 hours, when they spoke about going to the WSU football game. I asked Jacoba where Xana worked and he said at Mad Greek.

I asked both J and J if Xana had mentioned anything about having any issues with anyone or anything strange occuring lately. Both J and J said Xana had not said anything. J said Xana had a boyfriend, Ethan Chapman, who she had been dating for about six months or so. J said everything seemed fine with their relationship and J added how he had met was in town Ethan's parents in passing this weekend. It should be noted, J visiting as he resides in Avondale, AZ and it was Washington State University's Parent's Weekend. I asked Jacob and Jacob if there was anyone they wished me to contact for them or if they wished to speak with anyone such as a member of clergy. Both told me no. I gave them both my business card and informed them our detectives would be in contact with them in the near future. J and J then left the police department.
